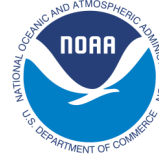

Key Achievements

- Implemented changes to platform, system architecture, and software to **develop a risk calculation rule engine from scratch** using complex logic and mathematical formulas, within 8 months -- ahead of the projected 18-month schedule.

- **Data Center Migration and Disaster Recovery:** Using an innovative method to migrate a 24x7x365 DHS biometric database sized in hundreds of terabytes to a new Data Center miles away with nearly no down-time. Set up real-time data replication between primary and DR data centers with the ability to perform instant switchover should a disaster recovery situation occur.
